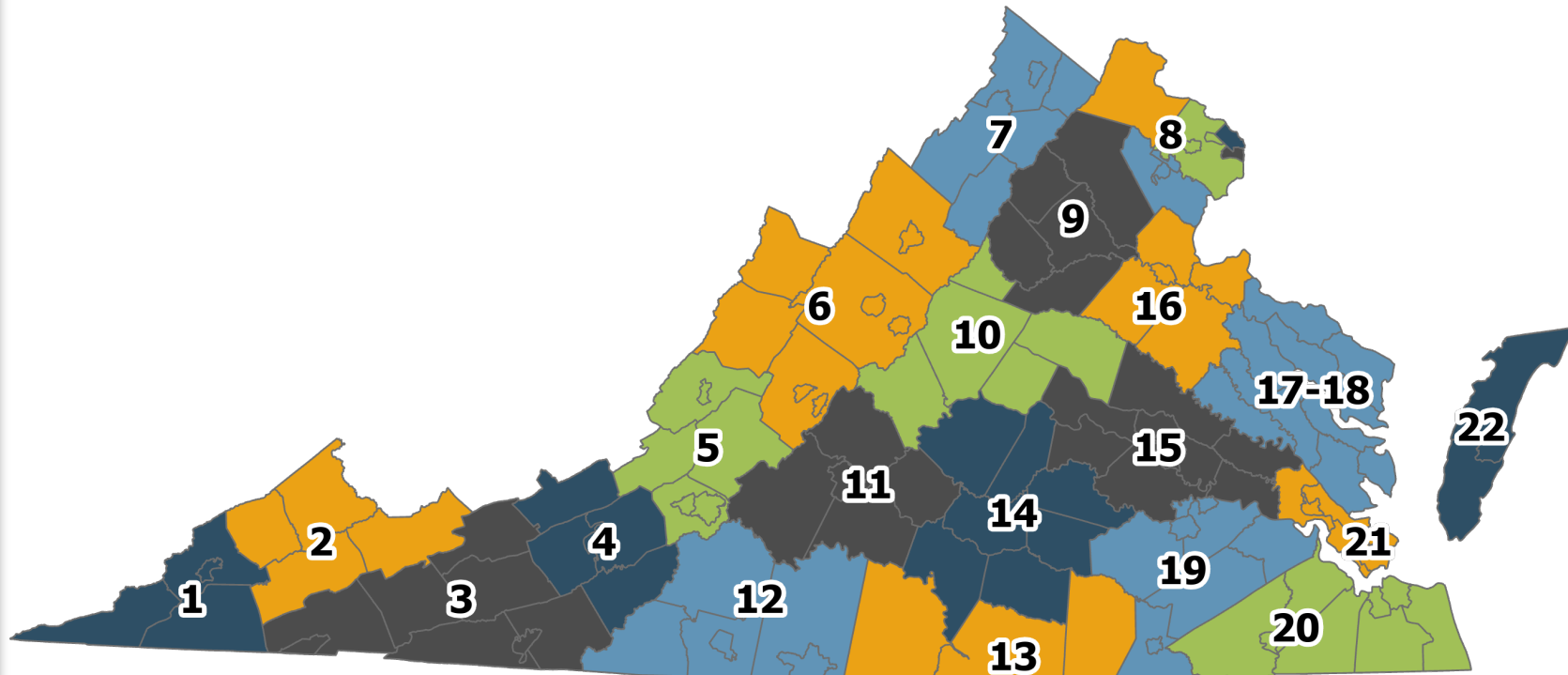

Planning and Service Area 12 (PSA) includes **Franklin County, Henry County, Patrick County, Pittsylvania County, Danville City, and Martinsville City.**

As of 2020, there were **74,445 Virginians aged 60+**, accounting for **31.1% of the total population** in PSA 12.<sup>1</sup>

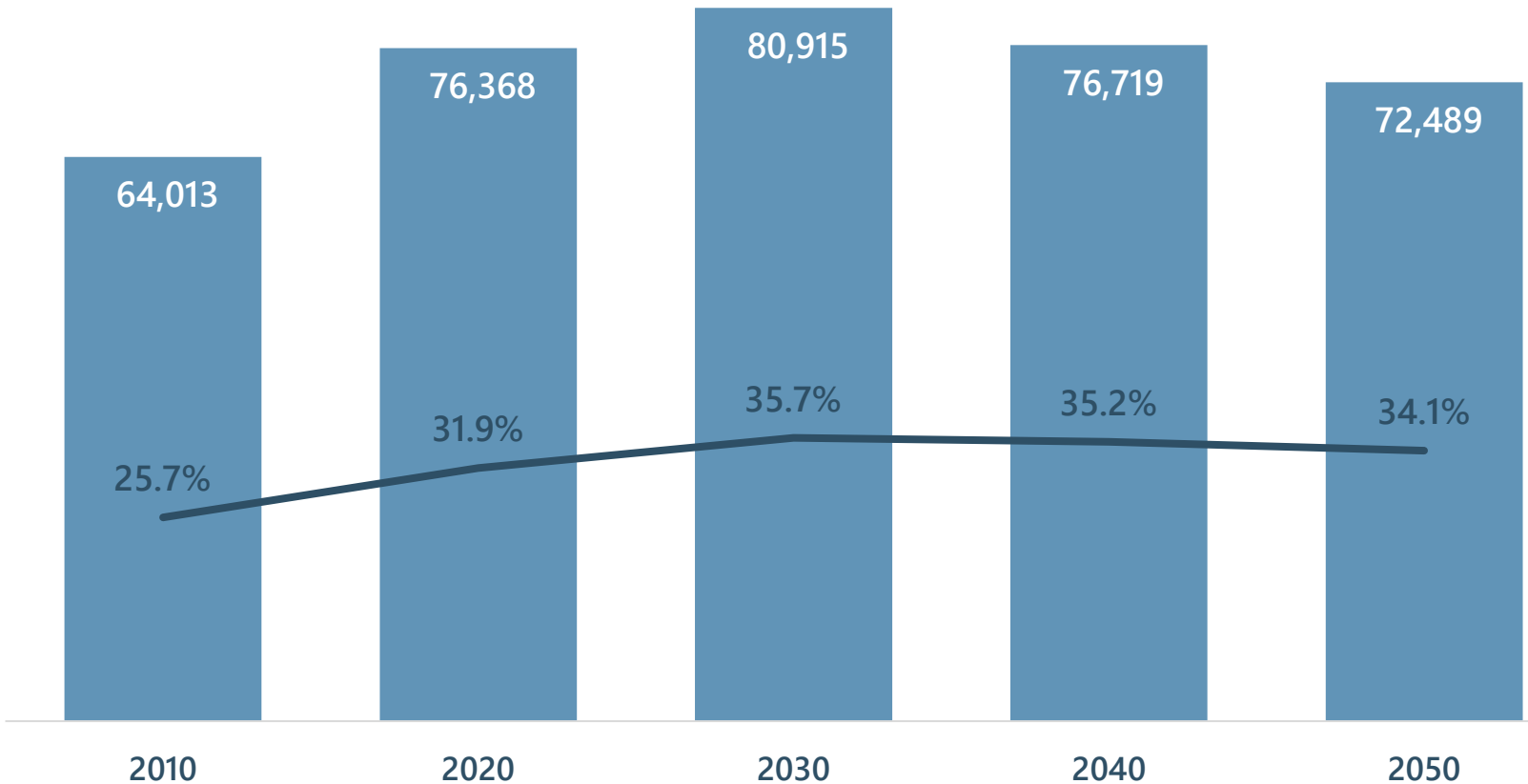


# POPULATION PROJECTIONS

By 2030, Virginians aged 60+ will comprise **35.7%** of the total population in PSA 12.<sup>2</sup>

The 60+ population in Virginia PSA 12 is **expected to decline slowly** as is the **rate of growth** between 2030 and 2050.<sup>2</sup>

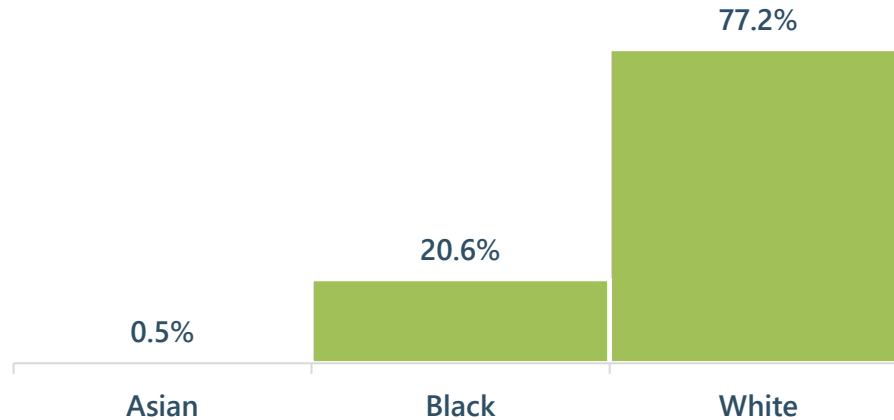

## GENDER, RACE, & HISPANIC ORIGIN



Percentage of 60+ Adults by Race & Hispanic Origin



**54.2%** of 60+ Virginians in PSA 12 were **women** and **45.8% men**.<sup>1</sup>

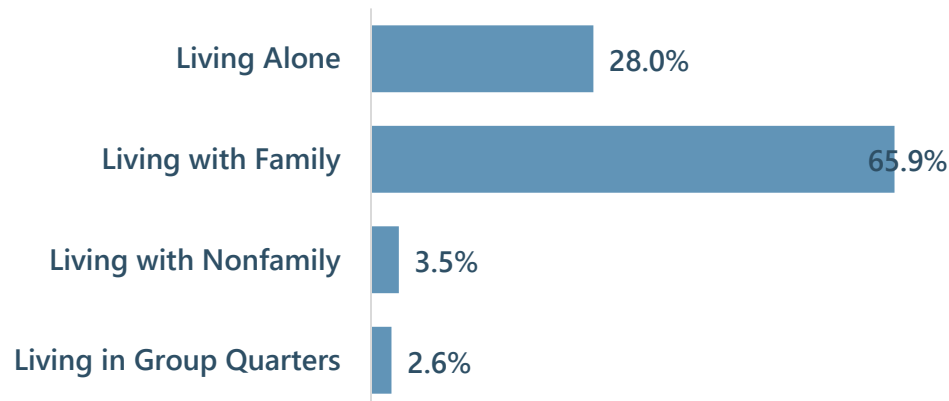
Among 60+ Virginians in PSA 12, **0.9%** were **Hispanic**.<sup>1</sup>

Other non-Hispanic racial groups consisted of less than 1%.<sup>1</sup>

## MARITAL STATUS & LIVING ARRANGEMENT



60+ Adults by Living Arrangement



**28%** of 60+ Virginians in PSA 12 **lived alone**.<sup>3</sup>

**53.1%** of 60+ Virginians in PSA 12 were married or partnered, followed by **23.7%** widowed, **14.3%** divorced, **5.6%** never married/single, and **3.3%** separated.<sup>3</sup>

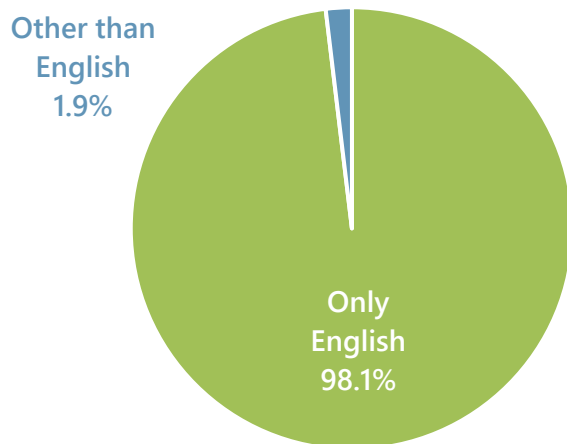

## LANGUAGE SPOKEN AT HOME



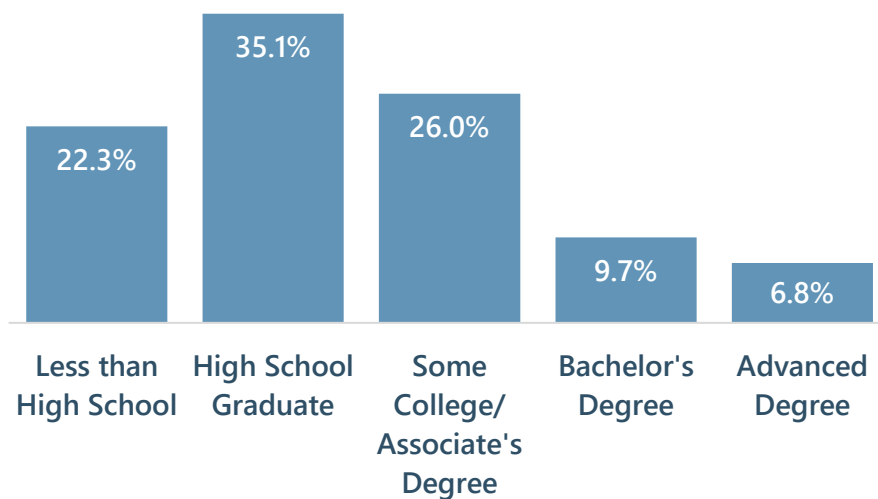
60+ Adults by Language Spoken Most at Home



**1.4%** of 60+ Virginians in PSA 12 were foreign-born immigrants.<sup>3</sup>

Among 60+ Virginians in PSA 12, **1.9%** said they mostly **spoke other languages** than English at home.<sup>3</sup>

## EDUCATIONAL ATTAINMENT



**22.3%** of 60+ Virginians in PSA 12 had less than a high school education.<sup>3</sup>

**6.8%** of 60+ Virginians in PSA 12 had graduate or professional degrees.<sup>3</sup>

## POVERTY & ECONOMIC STATUS

**11.9%** of 60+ Virginians in PSA 12 were **in poverty**.<sup>3</sup>



**10.2%** of households in PSA 12 with 60+ older adults **received food stamps or SNAP**.<sup>4</sup>

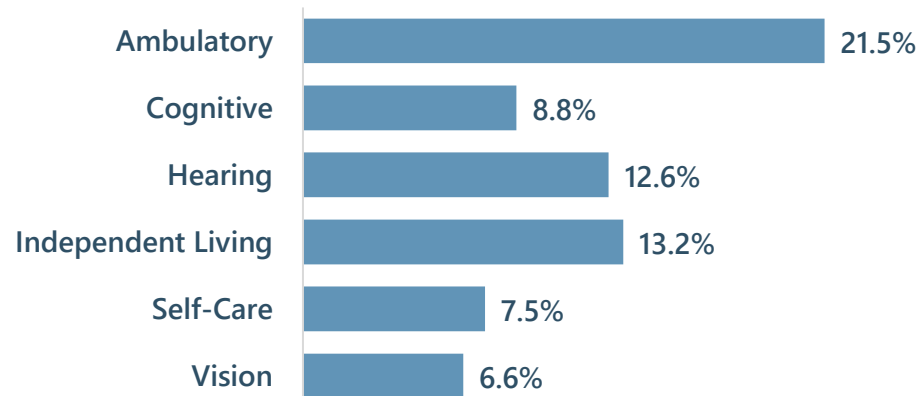


**18.5%** of 60+ householders in PSA 12 **rented** their houses.<sup>4</sup>

## DISABILITY & HEALTH



### 60+ Adults by Disability Type



**33.6%** of 60+ Virginians in PSA 12 had a **disability** and **17.3%** had **two or more types of disabilities**.<sup>3</sup>

Among those with a disability in PSA 12, **1.3%** had **no health insurance coverage**.<sup>3</sup>
