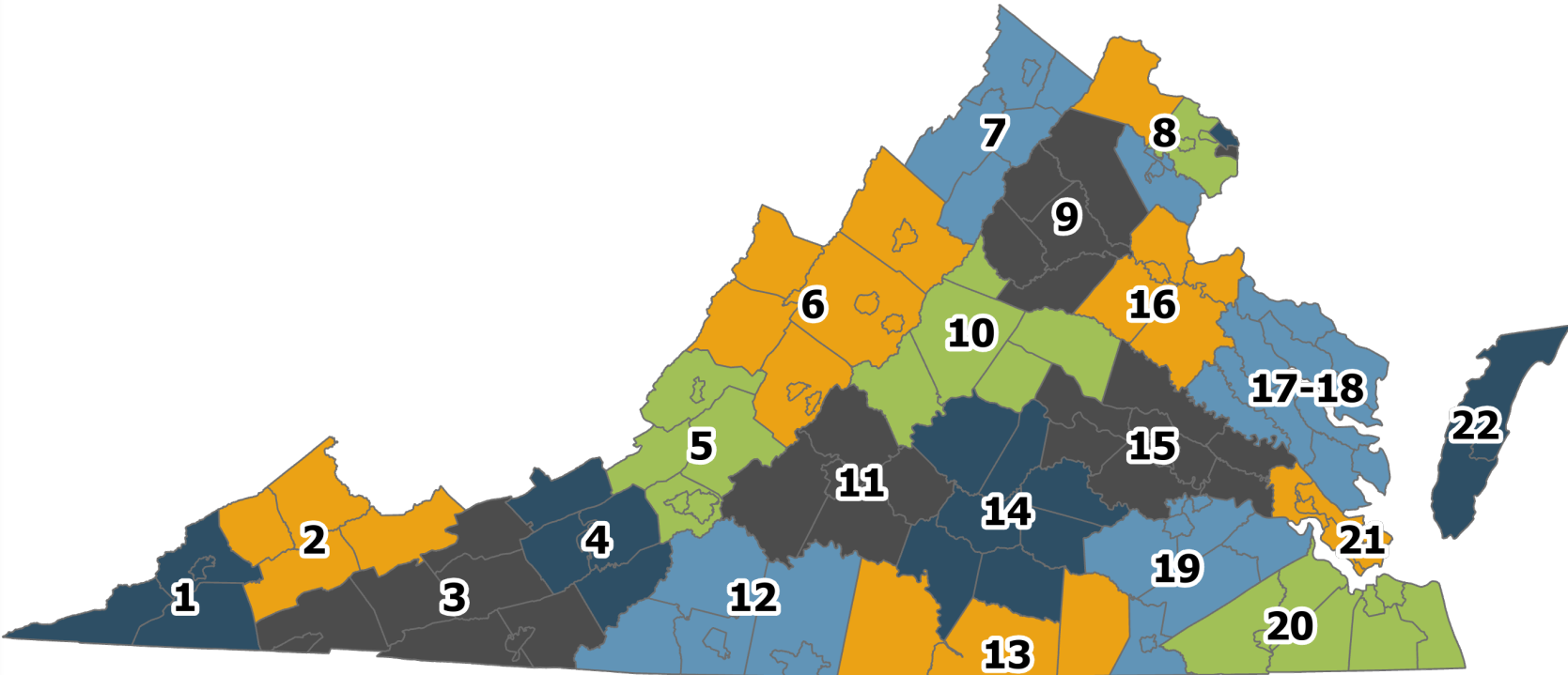

Planning and Service Area 3 (PSA) includes **Bland County, Carroll County, Grayson County, Smyth County, Washington County, Wythe County, Bristol City, and Galax City.**

As of 2020, there were **57,360 Virginians aged 60+**, accounting for **30.8% of the total population** in PSA 3.¹

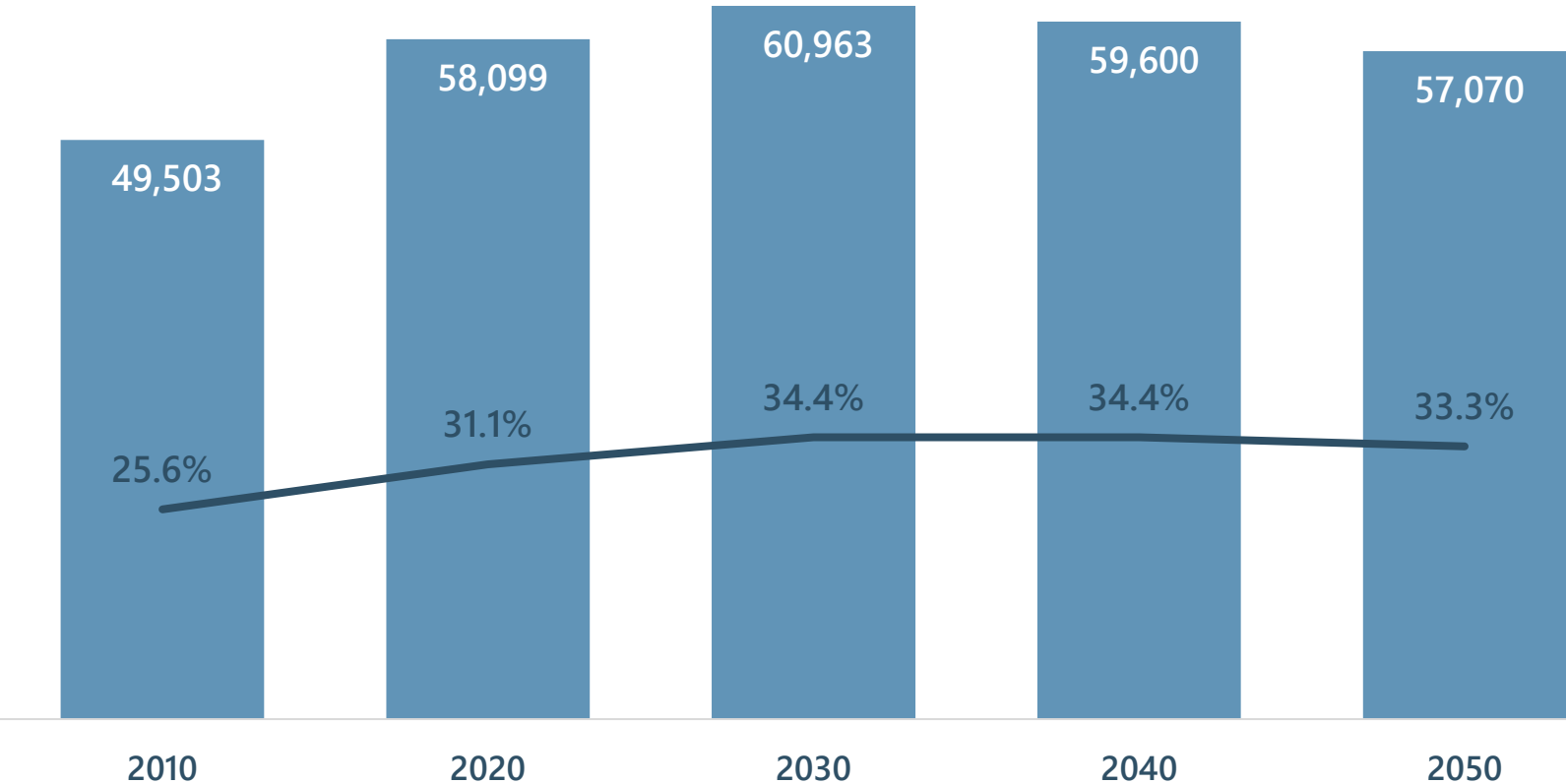

By 2030, Virginians aged 60+ will comprise **34.4%** of the total population in PSA 3.²

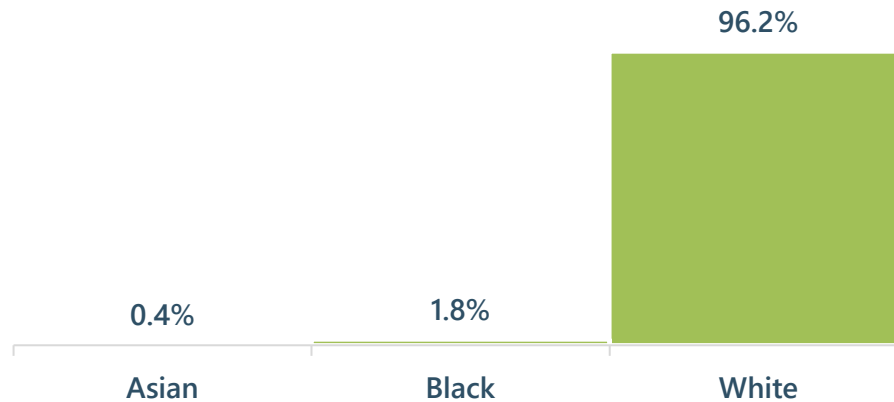
The 60+ population in Virginia PSA 3 is **expected to decline slowly** as is the **projected rate of growth** each successive decade until 2050.²



GENDER, RACE, & HISPANIC ORIGIN



Percentage of 60+ Adults by Race & Hispanic Origin



53.9% of 60+ Virginians in PSA 3 were **women** and **46.1% men**.¹

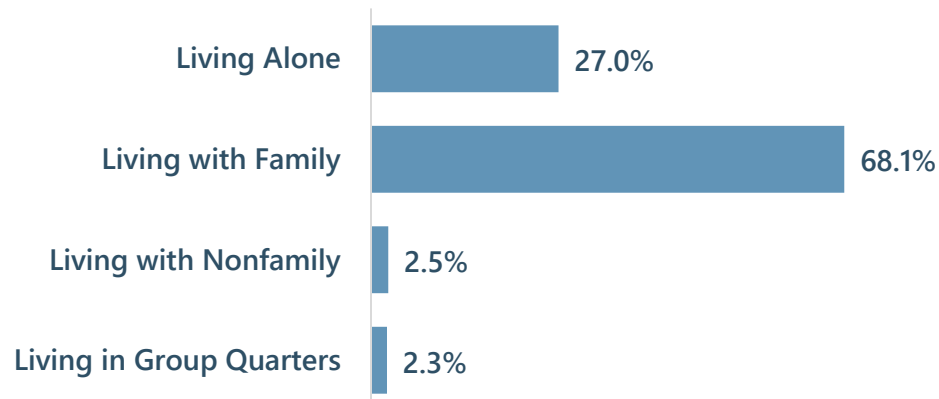
Among 60+ Virginians in PSA 3, **0.7%** were **Hispanic**.¹

Other non-Hispanic racial groups consisted of less than 1%.¹

MARITAL STATUS & LIVING ARRANGEMENT



60+ Adults by Living Arrangement



27% of 60+ Virginians in PSA 3 **lived alone**.³

57.4% of 60+ Virginians in PSA 3 were married or partnered, followed by **21.1%** widowed, **14.3%** divorced, **4.6%** never married/single, and **2.6%** separated.³

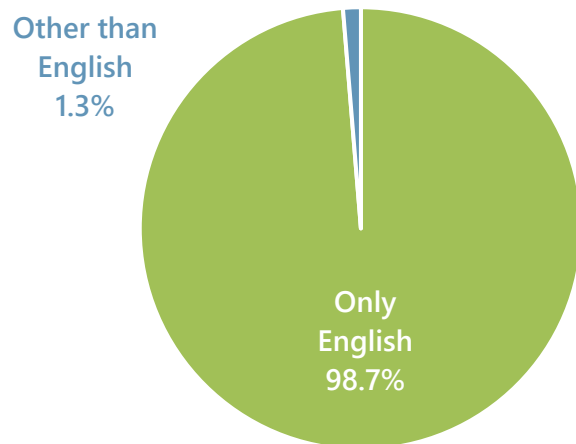

LANGUAGE SPOKEN AT HOME



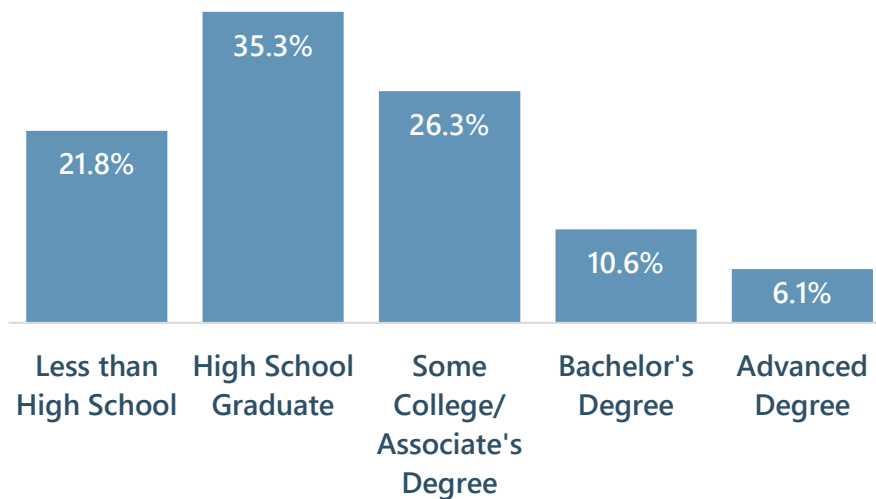
60+ Adults by Language Spoken Most at Home



1.1% of 60+ Virginians in PSA 3 were foreign-born immigrants.³

Among 60+ Virginians in PSA 3, **1.3%** said they mostly **spoke other languages** than English at home.³

EDUCATIONAL ATTAINMENT



21.8% of 60+ Virginians in PSA 3 had less than a high school education.³

6.1% of 60+ Virginians in PSA 3 had graduate or professional degrees.³

11.6% of 60+ Virginians in PSA 3 were **in poverty**.³



10% of households in PSA 3 with 60+ older adults **received food stamps or SNAP**.⁴

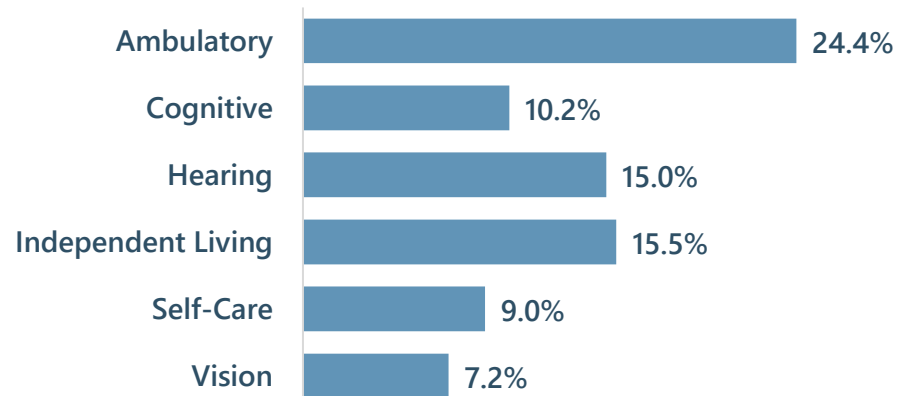


14.6% of 60+ householders in PSA 3 **rented** their houses.⁴

DISABILITY & HEALTH



60+ Adults by Disability Type



36.8% of 60+ Virginians in PSA 3 had a **disability** and **21.3%** had **two or more types of disabilities**.³

Among those with a disability in PSA 3, **2.4%** had **no health insurance coverage**.³
