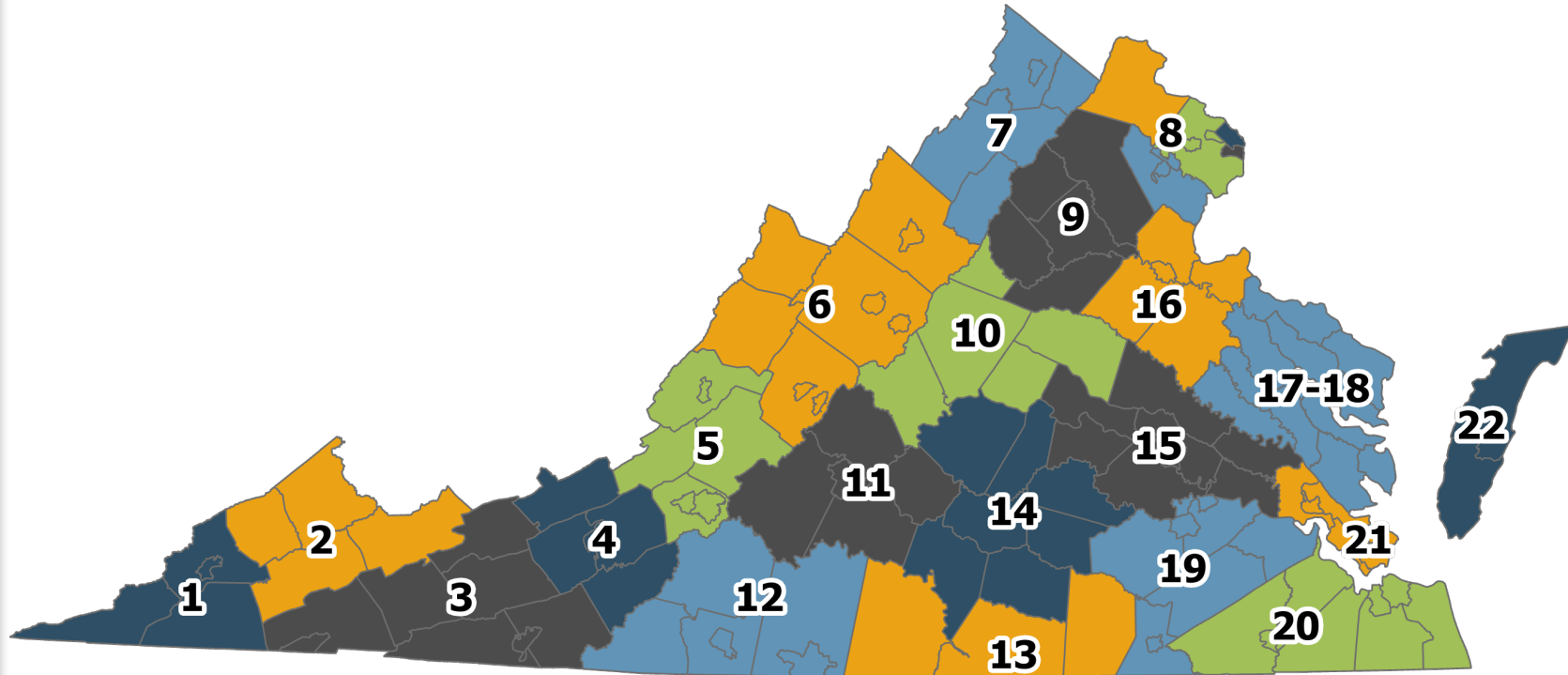

Planning and Service Area 4 (PSA) includes **Floyd County, Giles County, Montgomery County, Pulaski County, and Radford City.**

As of 2020, there were **40,511 Virginians aged 60+**, accounting for **22.3% of the total population** in PSA 4.<sup>1</sup>

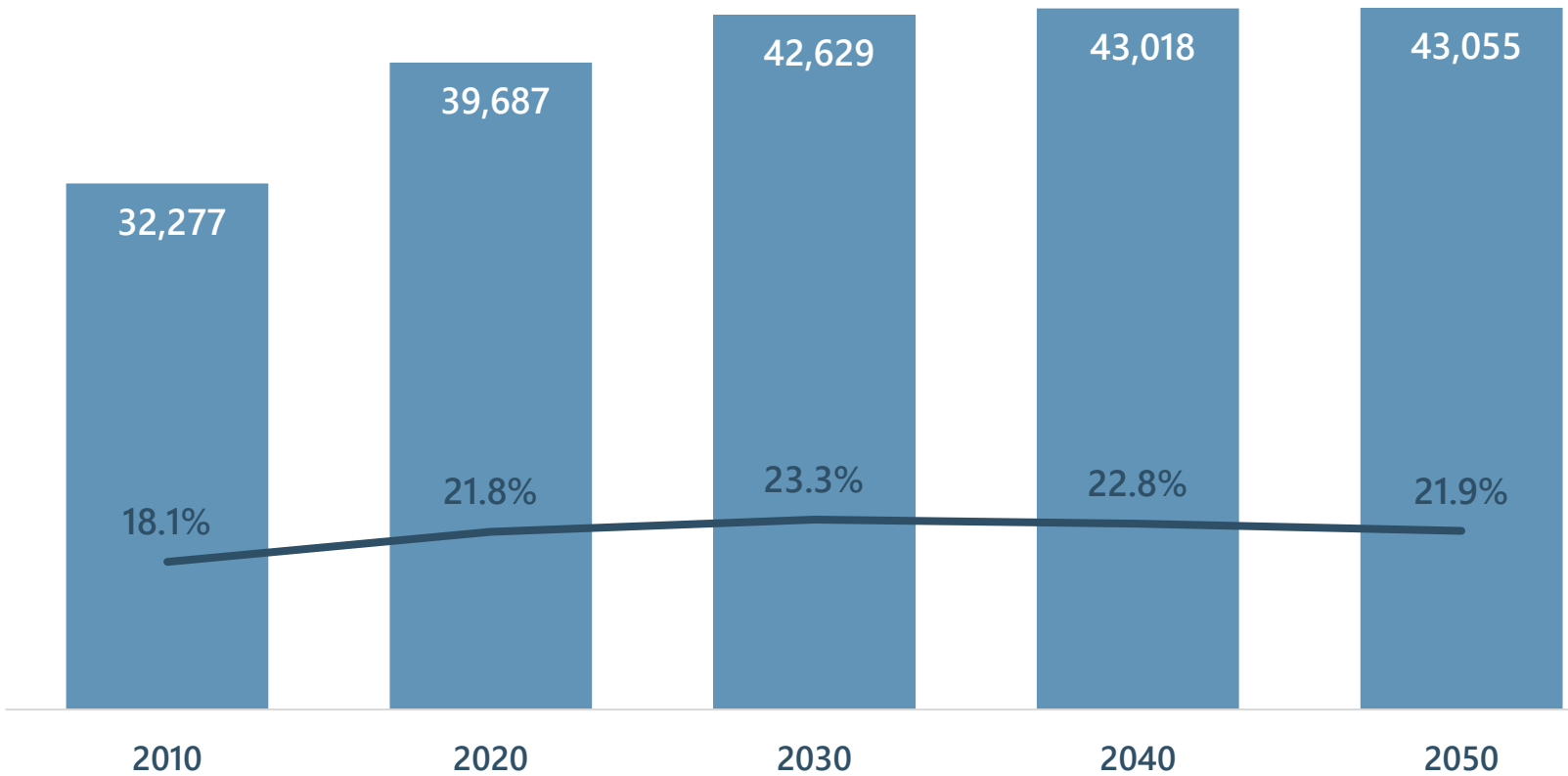


# POPULATION PROJECTIONS

By 2030, Virginians aged 60+ will comprise **23.3%** of the total population in PSA 4.<sup>2</sup>

The 60+ population in Virginia PSA 4 is **expected to grow steadily** but the **rate of growth is projected to decline** each successive decade until 2050.<sup>2</sup>

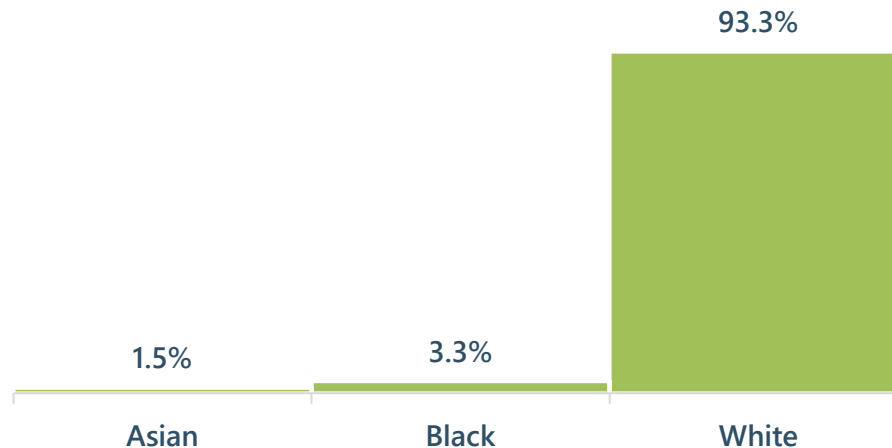

## GENDER, RACE, & HISPANIC ORIGIN



Percentage of 60+ Adults by Race & Hispanic Origin



**53.6%** of 60+ Virginians in PSA 4 were **women** and **46.4% men**.<sup>1</sup>

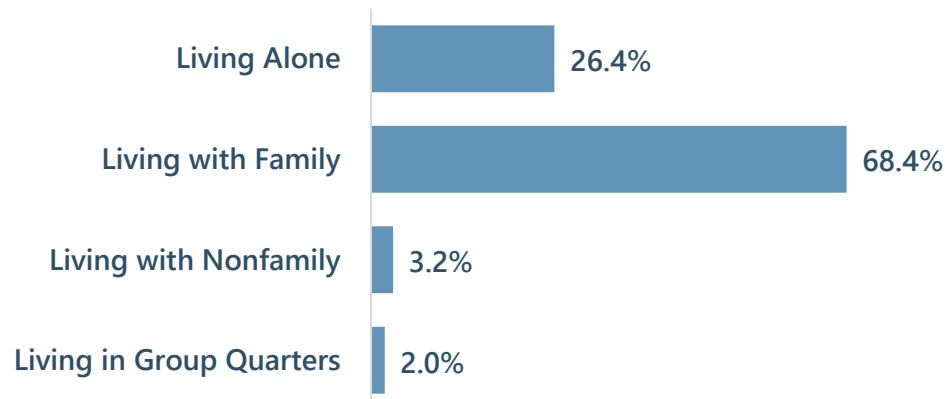
Among 60+ Virginians in PSA 4, **1%** were **Hispanic**.<sup>1</sup>

Other non-Hispanic racial groups consisted of less than 2%.<sup>1</sup>

## MARITAL STATUS & LIVING ARRANGEMENT



60+ Adults by Living Arrangement



**26.4%** of 60+ Virginians in PSA 4 **lived alone**.<sup>3</sup>

**55.2%** of 60+ Virginians in PSA 4 were married or partnered, followed by **21.2%** widowed, **13.7%** divorced, **6.7%** never married/single, and **3.3%** separated.<sup>3</sup>

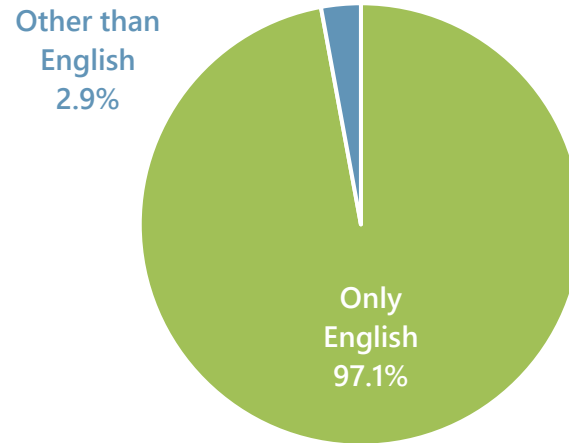

## LANGUAGE SPOKEN AT HOME



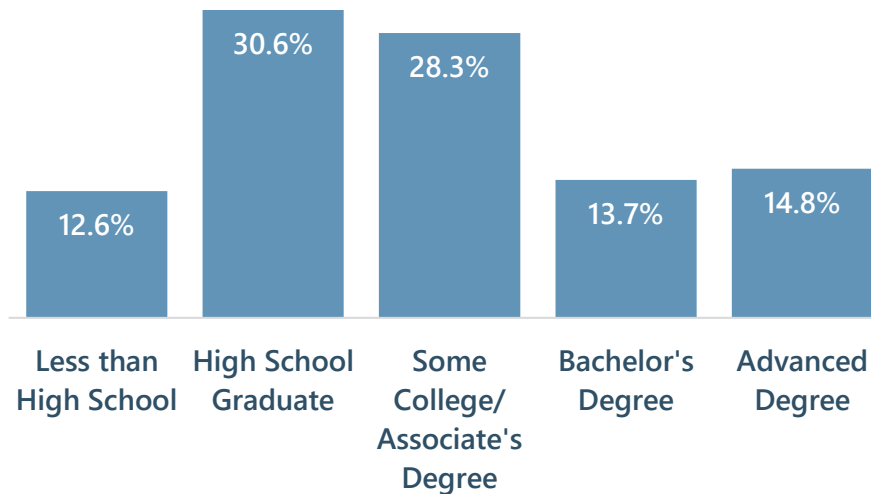
60+ Adults by Language Spoken Most at Home



**3.4%** of 60+ Virginians in PSA 4 were foreign-born immigrants.<sup>3</sup>

Among 60+ Virginians in PSA 4, **2.9%** said they mostly **spoke other languages** than English at home.<sup>3</sup>

## EDUCATIONAL ATTAINMENT



**12.6%** of 60+ Virginians in PSA 4 had less than a high school education.<sup>3</sup>

**14.8%** of 60+ Virginians in PSA 4 had graduate or professional degrees.<sup>3</sup>

## POVERTY & ECONOMIC STATUS

**7.8%** of 60+ Virginians in PSA 4 were **in poverty**.<sup>3</sup>



**6%** of households in PSA 4 with 60+ older adults **received food stamps or SNAP**.<sup>4</sup>

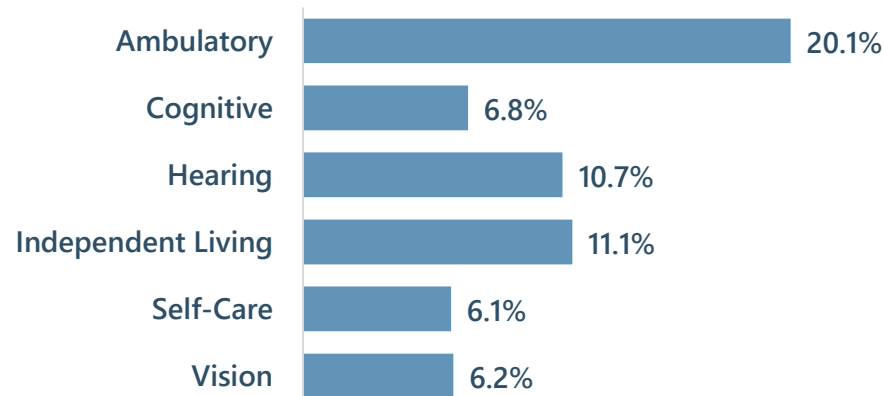


**15%** of 60+ householders in PSA 4 **rented** their houses.<sup>4</sup>

## DISABILITY & HEALTH



### 60+ Adults by Disability Type



**30%** of 60+ Virginians in PSA 4 had a **disability** and **14.5%** had **two or more types of disabilities**.<sup>3</sup>

Among those with a disability in PSA 4, **1.8%** had **no health insurance coverage**.<sup>3</sup>
