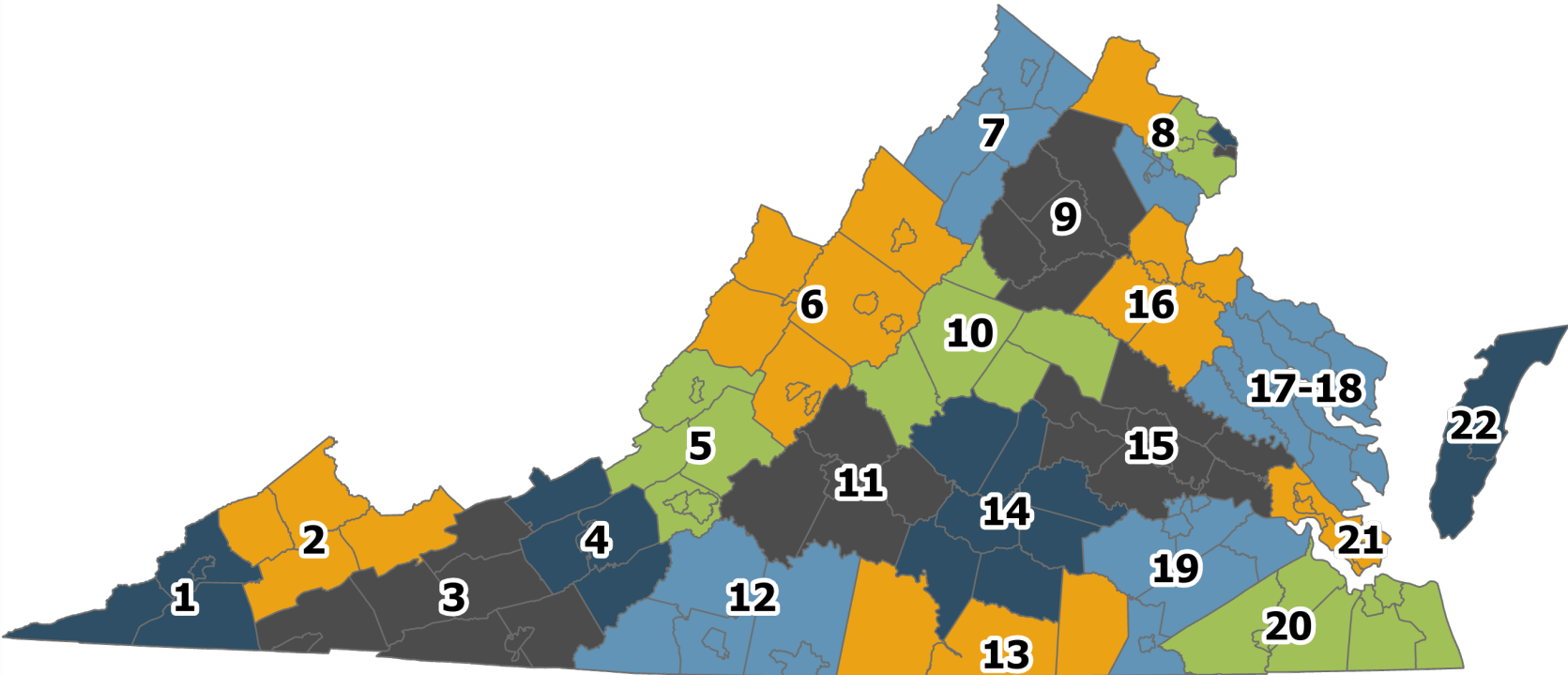

Planning and Service Area 6 (PSA) includes **Augusta County, Bath County, Highland County, Rockbridge County, Buena Vista City, Harrisonburg City, Lexington City, Staunton City, and Waynesboro City.**

As of 2020, there were **77,285 Virginians aged 60+**, accounting for **25.4% of the total population** in PSA 6.<sup>1</sup>

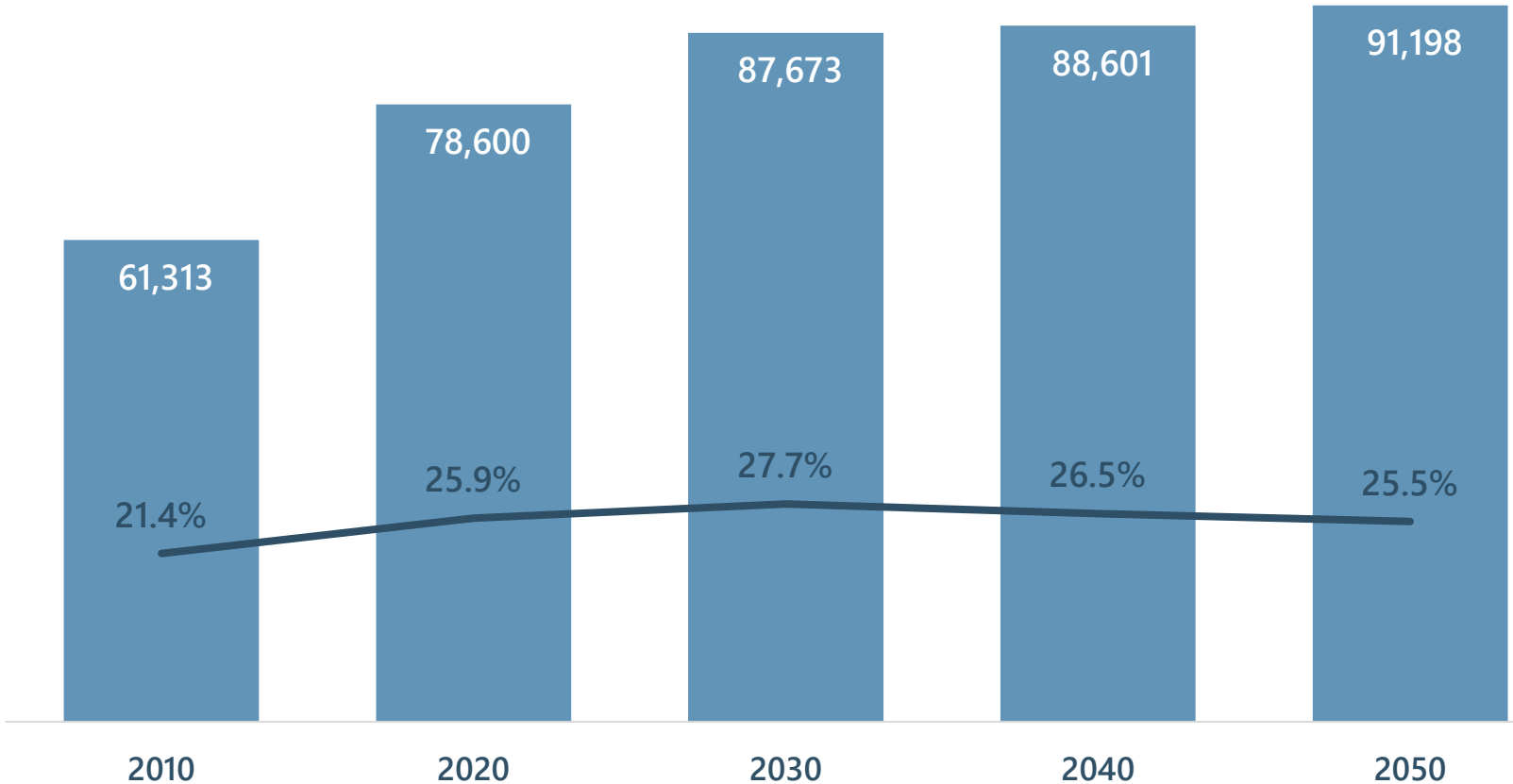


# POPULATION PROJECTIONS

By 2030, Virginians aged 60+ will comprise **27.7%** of the total population in PSA 6.<sup>2</sup>

The 60+ population in Virginia PSA 6 is **expected to grow steadily** but the **rate of growth is projected to decline** each successive decade until 2050.<sup>2</sup>

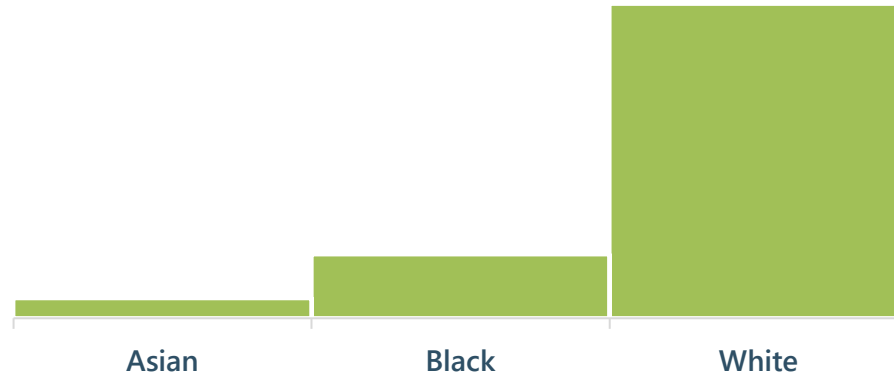

## GENDER, RACE, & HISPANIC ORIGIN

**53.4%** of 60+ Virginians in PSA 6 were **women** and **46.6% men**.<sup>1</sup>

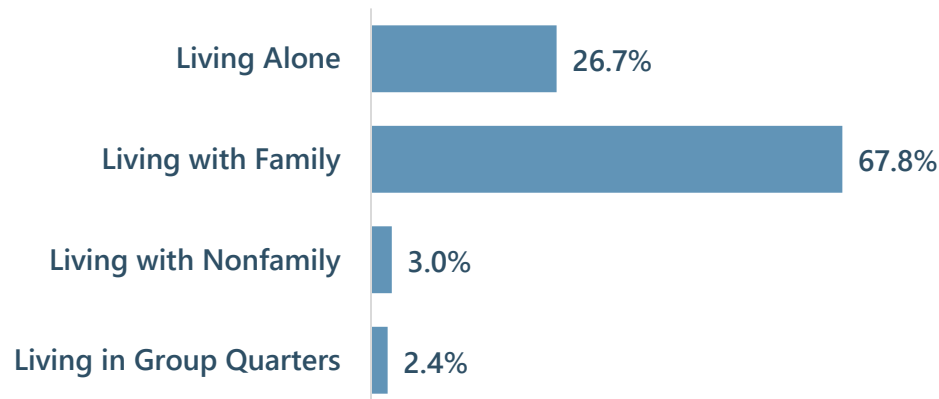
Among 60+ Virginians in PSA 1, **3.8%** were **Hispanic**.<sup>1</sup>

Other non-Hispanic racial groups consisted of less than 2%.<sup>1</sup>

## MARITAL STATUS & LIVING ARRANGEMENT



60+ Adults by Living Arrangement



**26.7%** of 60+ Virginians in PSA 6 **lived alone**.<sup>3</sup>

**56.4%** of 60+ Virginians in PSA 6 were married or partnered, followed by **20.5%** widowed, **14.4%** divorced, **5.7%** never married/single, and **3.1%** separated.<sup>3</sup>

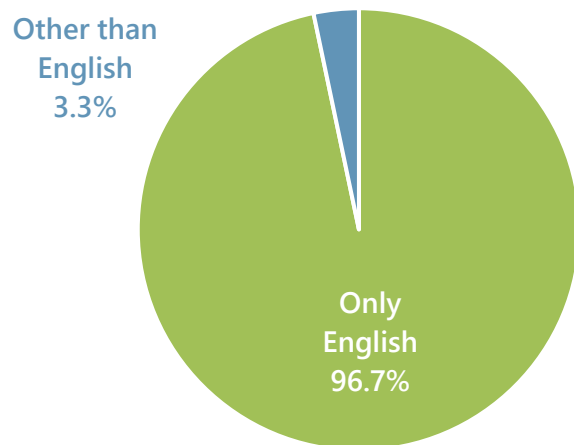

## LANGUAGE SPOKEN AT HOME



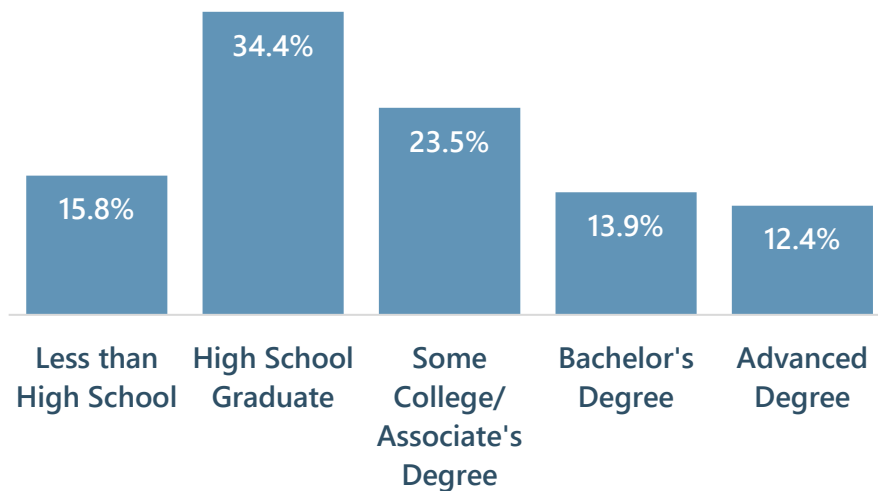
60+ Adults by Language Spoken Most at Home



**3.8%** of 60+ Virginians in PSA 6 were foreign-born immigrants.<sup>3</sup>

Among 60+ Virginians in PSA 6, **3.3%** said they mostly **spoke other languages** than English at home.<sup>3</sup>

## EDUCATIONAL ATTAINMENT



**15.8%** of 60+ Virginians in PSA 6 had less than a high school education.<sup>3</sup>

**12.4%** of 60+ Virginians in PSA 6 had graduate or professional degrees.<sup>3</sup>

**7.8%** of 60+ Virginians in PSA 6 were **in poverty**.<sup>3</sup>



**6.1%** of households in PSA 6 with 60+ older adults **received food stamps or SNAP**.<sup>4</sup>

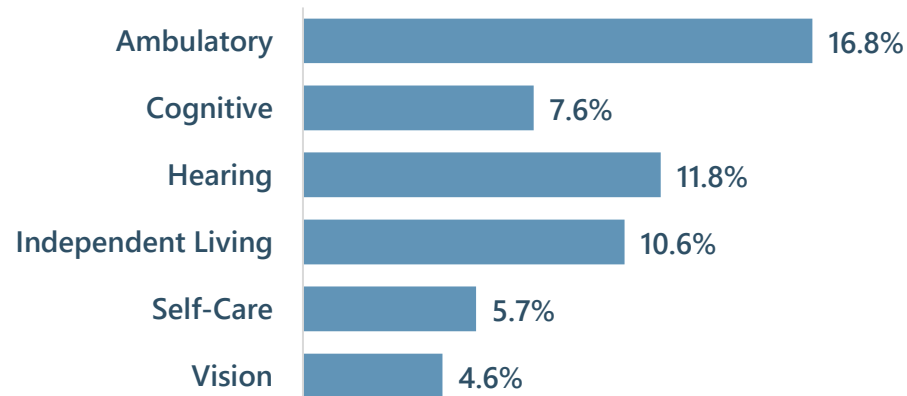


**19.8%** of 60+ householders in PSA 6 **rented** their houses.<sup>4</sup>

## DISABILITY & HEALTH



### 60+ Adults by Disability Type



**28.7%** of 60+ Virginians in PSA 6 had a **disability** and **14.1%** had **two or more types of disabilities**.<sup>3</sup>

Among those with a disability in PSA 6, **1.5%** had **no health insurance coverage**.<sup>3</sup>
