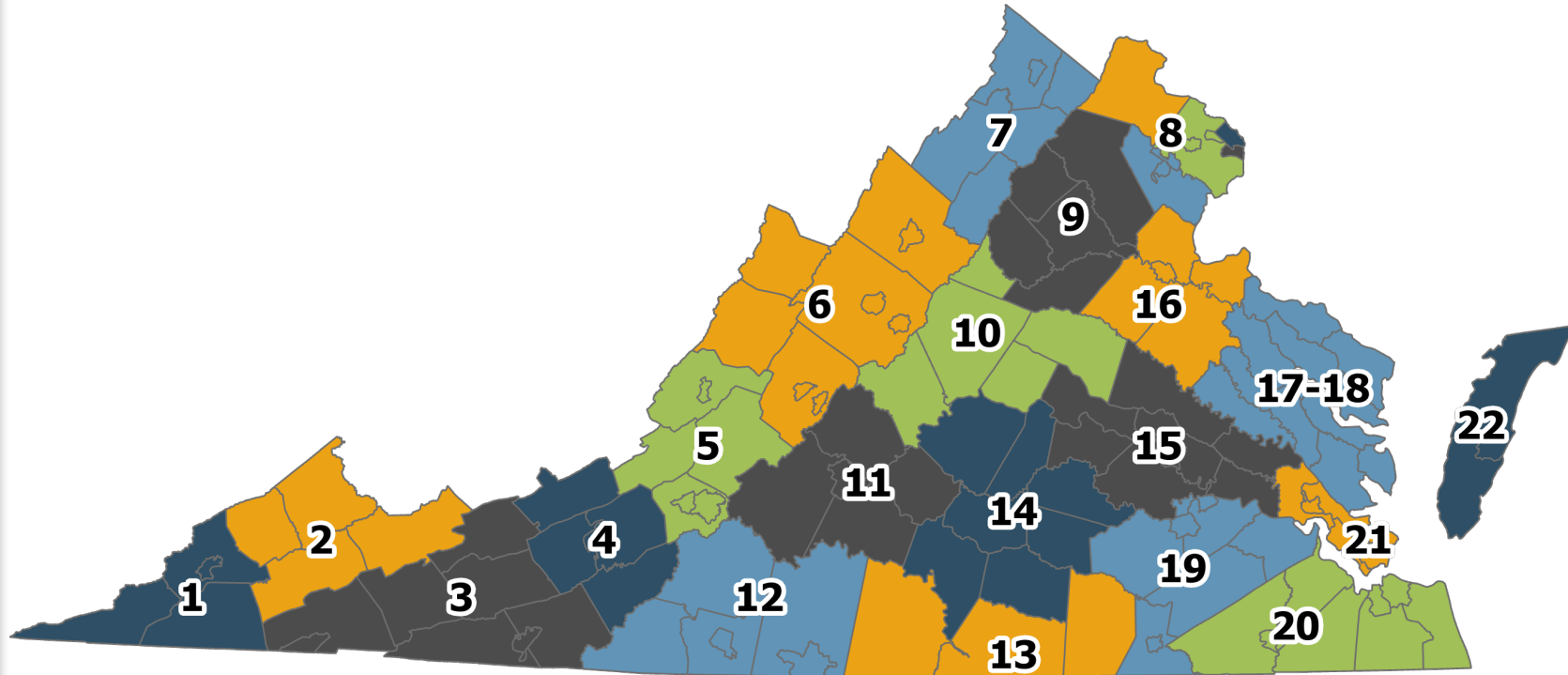

Planning and Service Area 8C (PSA) includes **Fairfax County, Fairfax City,** and **Falls Church.**

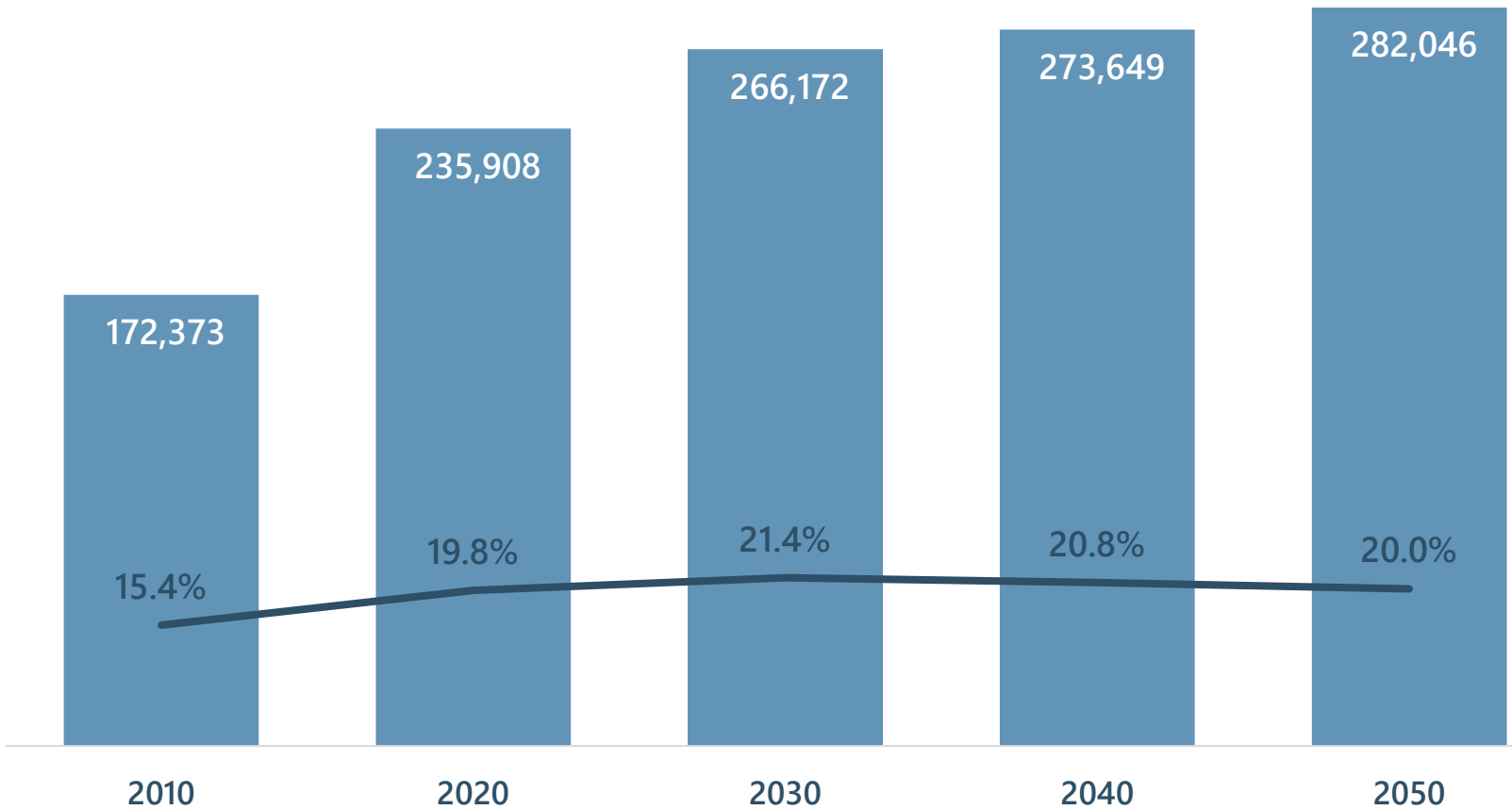
As of 2020, there were **237,173** Virginians aged 60+, accounting for **20% of the total population** in PSA 8C.<sup>1</sup>

By 2030, Virginians aged 60+ will comprise **21.4%** of the total population in PSA 8C.<sup>2</sup>

The 60+ population in Virginia PSA 8C is **expected to grow** but the **rate of growth is projected to decline** each successive decade until 2050.<sup>2</sup>

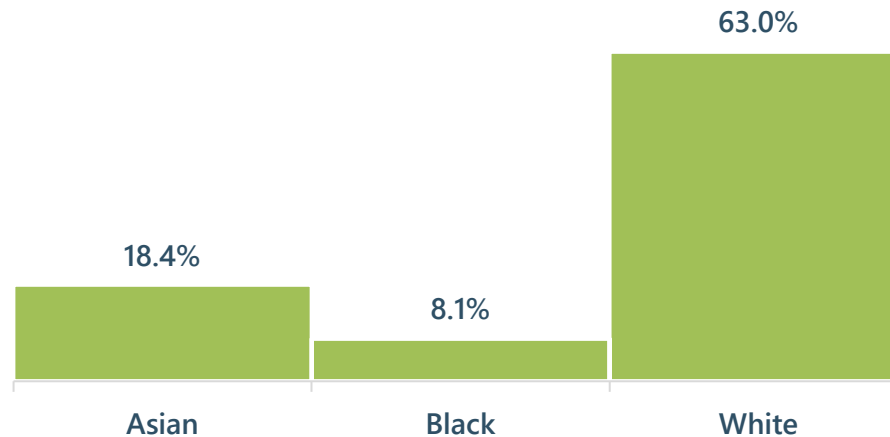

## GENDER, RACE, & HISPANIC ORIGIN



Percentage of 60+ Adults by Race & Hispanic Origin



**52.8%** of 60+ Virginians in PSA 8C were **women** and **47.2% men**.<sup>1</sup>

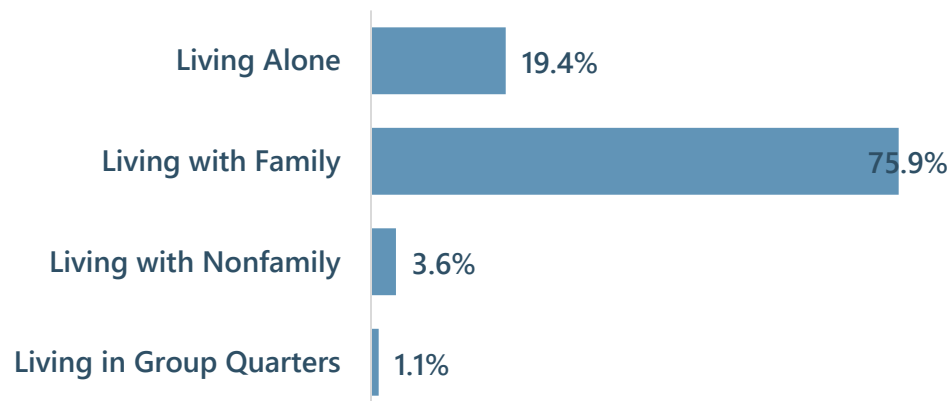
Among 60+ Virginians in PSA 8C, **9.1%** were **Hispanic**.<sup>1</sup>

Other non-Hispanic racial groups consisted of less than 2%.<sup>1</sup>

## MARITAL STATUS & LIVING ARRANGEMENT



60+ Adults by Living Arrangement



**19.4%** of 60+ Virginians in PSA 8C **lived alone**.<sup>3</sup>

**61.1%** of 60+ Virginians in PSA 8C were married or partnered, followed by **14.5%** widowed, **12.7%** divorced, **7%** never married/single, and **4.7%** separated.<sup>3</sup>

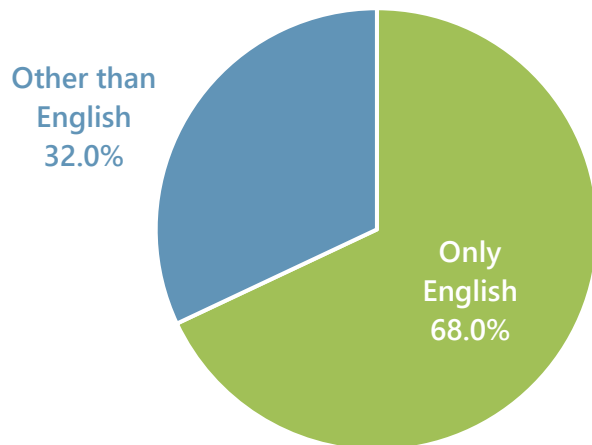

## LANGUAGE SPOKEN AT HOME



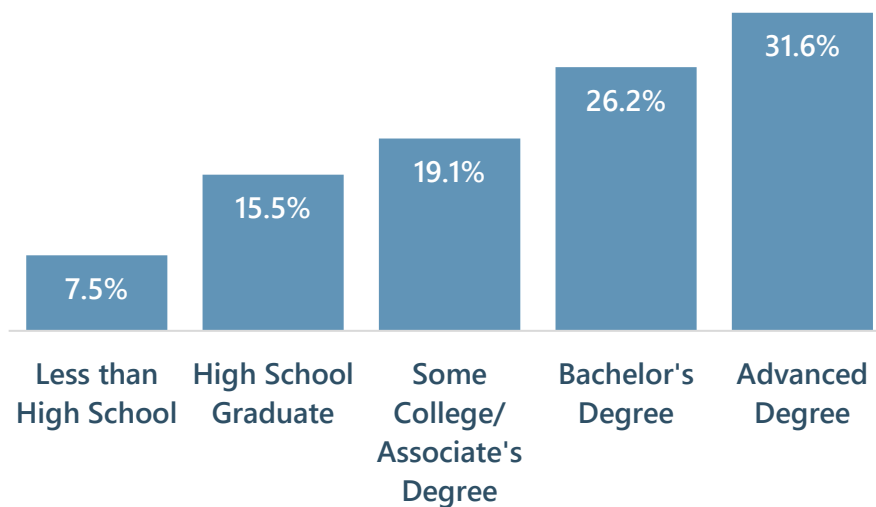
60+ Adults by Language Spoken Most at Home



**33.8%** of 60+ Virginians in PSA 8C were foreign-born immigrants.<sup>3</sup>

Among 60+ Virginians in PSA 8C, **32%** said they mostly **spoke other languages** than English at home.<sup>3</sup>

## EDUCATIONAL ATTAINMENT



**7.5%** of 60+ Virginians in PSA 8C had less than a high school education.<sup>3</sup>

**31.6%** of 60+ Virginians in PSA 8C had graduate or professional degrees.<sup>3</sup>

## POVERTY & ECONOMIC STATUS

**4.6%** of 60+ Virginians in PSA 8C were **in poverty**.<sup>3</sup>



**3.9%** of households in PSA 8C with 60+ older adults **received food stamps or SNAP**.<sup>4</sup>

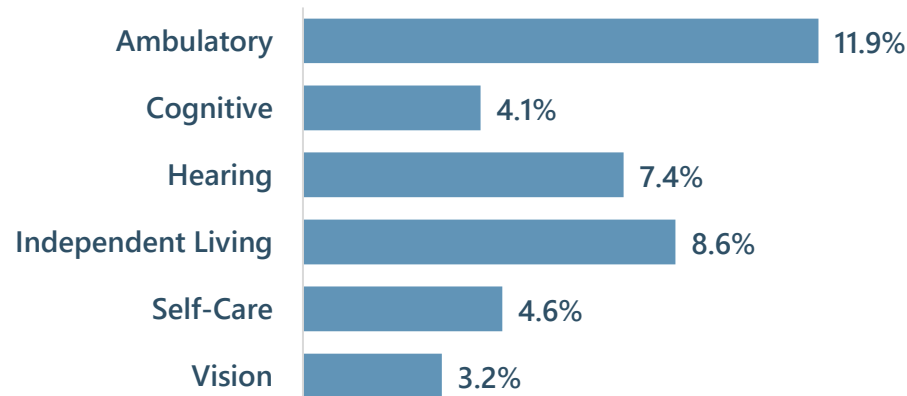


**16.4%** of 60+ householders in PSA 8C **rented** their houses.<sup>4</sup>

## DISABILITY & HEALTH



### 60+ Adults by Disability Type



**20.2%** of 60+ Virginians in PSA 8C had a **disability** and **9.6%** had **two or more types of disabilities**.<sup>3</sup>

Among those with a disability in PSA 8C, **2.3%** had **no health insurance coverage**.<sup>3</sup>
